



2010 On-Site Mare Breeding Contract

1. I hereby agree to breed my mare: _____, Reg. # _____, Year Foaled _____, to the Stallion _____, via artificial insemination by SDP Buffalo Ranch during 2010. I agree to pay \$ _____,00 made payable to SDP Buffalo Ranch for the Breed Fee. **Included** in the Breed Fee is a **\$600.00** Chute Fee. *The Chute Fee must accompany this contract when it is returned to SDP Buffalo Ranch. The balance of the Breed Fee is due prior to the first shipment of semen.* The Chute Fee is non-refundable. The Breed Fee shall, however, entitle me to the SDP Buffalo Ranch Live Foal Guarantee (see paragraph #7).

2. Is this mare to be an embryo transfer? Yes No (circle one).
If yes, name of embryo transfer facility: _____. In the event multiple embryos are recovered from this contract, an additional stud fee will be due upon birth of said foal(s).

3. SDP Buffalo Ranch agrees to breed my mare up to and including **July 15**, unless otherwise arranged at time of signing of this contract. I further agree to give SDP Buffalo Ranch ample opportunity to settle her (having bred her through at least three heat periods). If however, for any reason she does not settle, I will hold SDP Buffalo Ranch harmless.

4. Mares that are not halter broke will not be accepted for breeding.

5. **Up-to-date vaccinations and a negative coggins test are required before a mare is allowed on to SDP Buffalo Ranch.**

6. It is further agreed that should the above named stallion die or become unfit for service, or if my mare should die or become unfit to breed, then this contract shall become null and void, and any money paid as part of this service (except Chute Fee and shipping expenses) shall be applied to another stallion standing at SDP Buffalo Ranch and shall be deemed a credit and I will be entitled to a rebreed or substitution the following year.

7. It is also agreed that I am guaranteed a live foal at the time of the signing of this contract and that if my foal does not stand and suck, I will be entitled subsequent return in season to the same mare (unless mutually agreed) until a healthy live foal is achieved. **THIS GUARANTEE WILL APPLY ONLY IF I NOTIFY SDP BUFFALO RANCH WITHIN ONE (1) WEEK FROM DEATH; THIS NOTICE MUST BE ACCOMPANIED BY A STATEMENT FROM A LICENSED VETERINARIAN.** There shall be no liability upon SDP Buffalo Ranch on account of said guarantee except to grant me a free season for 1 mare until a successful healthy live foal is achieved. Said free season shall refer to the Breeding Fees only, a Chute Fee the subsequent season shall apply. **ALL Rebreds are to be administered on-site at SDP Buffalo Ranch, no shipped semen. A Rebreed Contract must be filled out and returned to SDP Buffalo Ranch immediately.**

8. The mare's registration certificate showing owner at time of breeding or a photostat copy, both sides, thereof, must be furnished and returned with this contract.

9. I agree not to assign or transfer this contract without prior consent of SDP Buffalo Ranch.

10. I agree and understand that neither SDP Buffalo Ranch, its representatives, nor the Stallion Owner(s) will be responsible for accidents, sickness, death, or acts of God to my mare and or foal. However SDP Buffalo Ranch and its representatives will use all means of expertise and care to prevent misfortune.

11. This agreement is made within the governing of Texas Law, shall be performable within Tarrant County, Texas.

12. **MARE WILL NOT DEPART SDP BUFFALO RANCH UNTIL THE BREED FEE AND OTHER MARE CARE CHARGES ARE PAID IN FULL AND A SIGNED CONTRACT AND COPY OF MARE'S REGISTRATION PAPERS ARE ON FILE AT SDP BUFFALO RANCH.** SDP Buffalo Ranch requires 48 hours advance notice when the Mare Owner wishes to remove his or her mare(s) from the farm. SDP Buffalo Ranch will not release the mare until all fees have been paid in full to SDP Buffalo Ranch. This will allow staff sufficient time to prepare the required health papers and final statement to settle all accounts.
